Dear Parent or Guardian:

We want to welcome you and your child to our Mosaic Student Skate Park. It is our desire that this new outdoor space be available to students in our community to skateboard and have fun in a safe environment. In order to make that happen we need to receive a signed waiver for every skater. In return, we will provide each skater with a sticker to place on their skateboard or helmet to identify their having a waiver on file.

In addition, it is important that you and your skater read the following rules and agree to them to ensure that we maintain a safe environment for everyone.

Rules:

- Skaters 13 & under must have parent/guardian supervision
- All skaters **MUST** have a signed waiver on file
- SKATEBOARDS + SCOOTERS + INLINE SKATING only
- **NO:** graffiti, tagging, or stickers
- Glass containers are **NOT** permitted
- No one permitted in park when posted closed
- Profanity, obscene language + inappropriate behavior is **NOT** allowed
- **NO** smoking, alcohol, or illegal substances allowed
- Mandatory Equipment for all Skaters: **helmet, knee pads, elbow pads**

Hours: Our intention is to have the park open most weekdays after school until 8:00 p.m. and on weekends from noon to 8:00 p.m.

We will post a "**CLOSED**" sign when the park is not open.

I, for myself and on behalf of my heirs, assigns, personal representatives and their next of kin, HEREBY RELEASE AND HOLD HARMLESS PRINCETON PRESBYTERIAN CHURCH (here and after, referred to as PPC) and any and all related entities, officers, directors, employees, other participants sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event ("Releases"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASES OR OTHERWISE.

2. The risk of injury from the activities involved in this program is significant, (SKATE/RIDE AT YOUR OWN RISK), as action sports are known to be hazardous, major accidents occur in most sports, including the potential for permanent paralysis and death. While particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown. EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASES or others, and assume full responsibility for my participation; and

4. I willingly agree to comply with the stated and customary terms and conditions for participation. If however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately, and agree to release ownership of all participant images, photos and videos taken in the park to be used on miscellaneous marketing material, website, video productions as a complete photography release, and I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
